4. The website provides contact information and next steps to apply for these programs.[2](#)

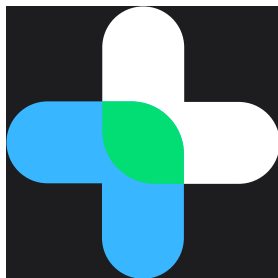
### Privacy and Security

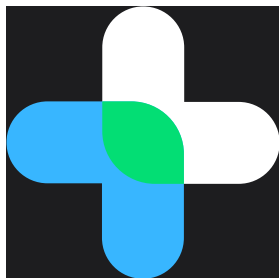

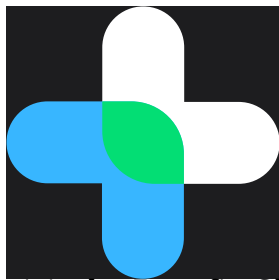
